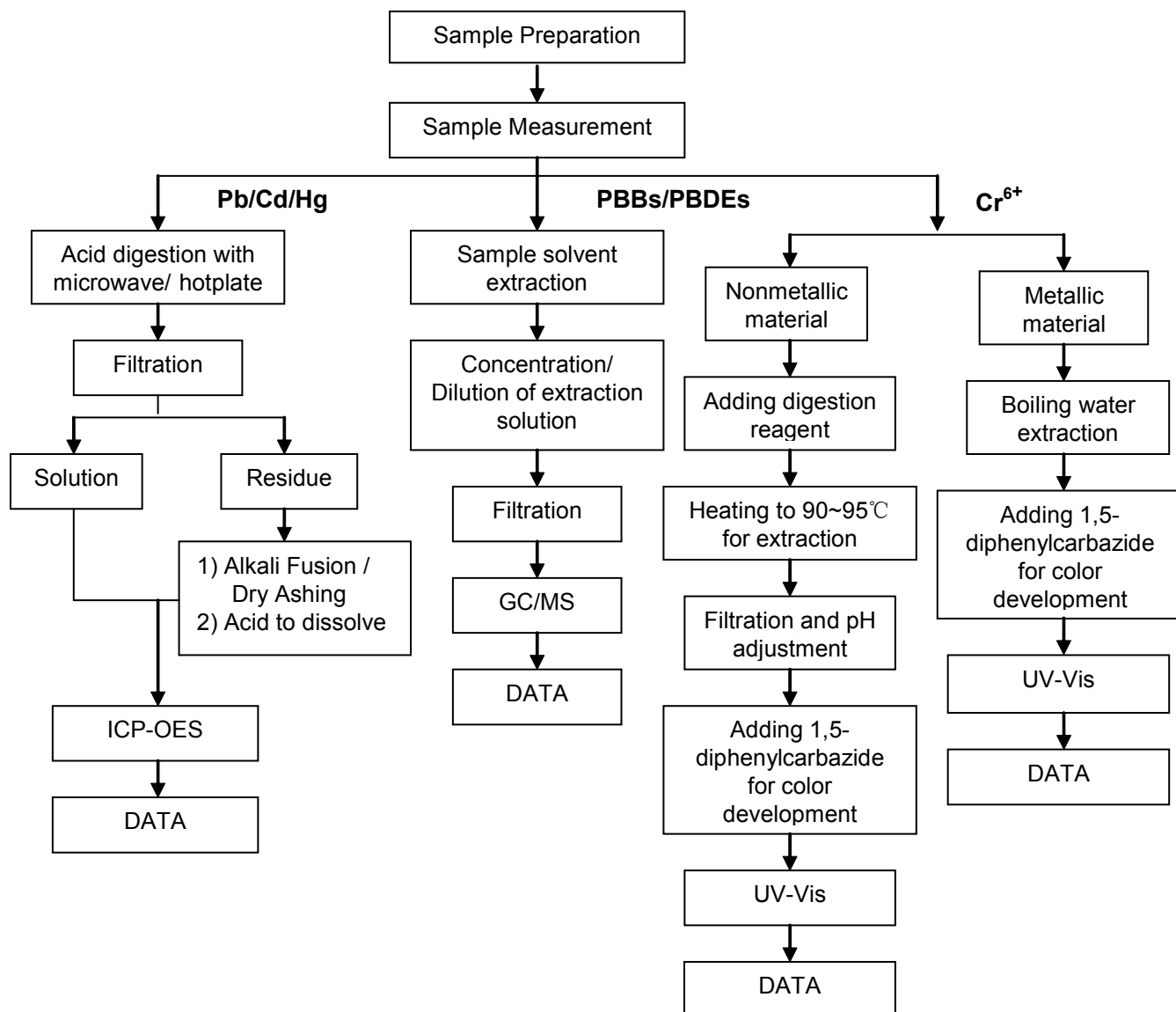

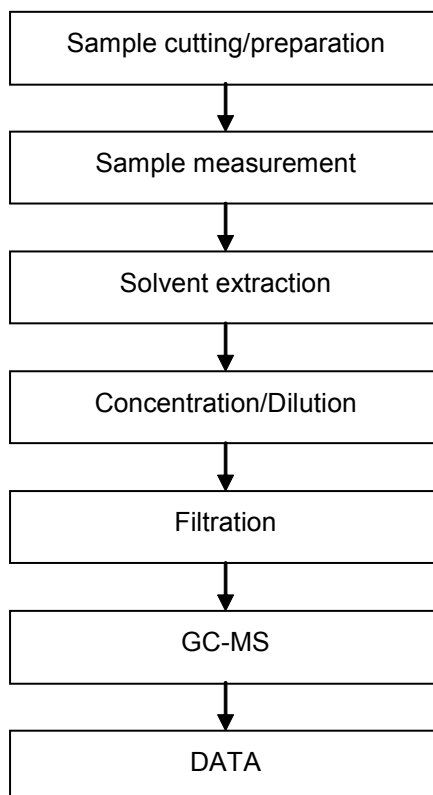
### RoHS Testing Flow Chart

### Phthalates Testing Flow Chart



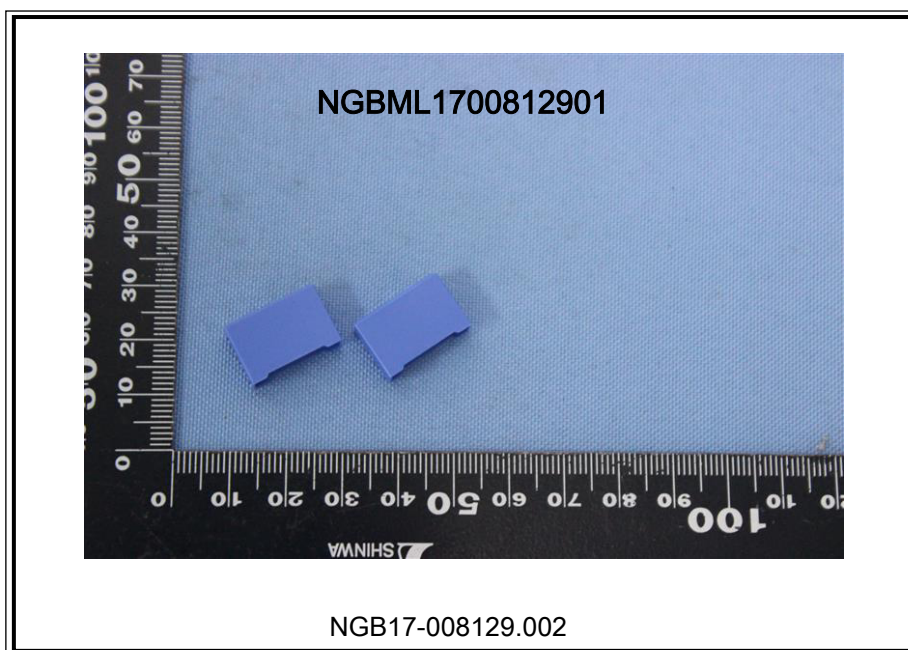
